The need to improve energy security and reduce the environmental impact of the energy sector is acute. Renewable energy can play a key role in addressing both these issues.

The Ukraine Sustainable Energy Lending Facility (USELF) is part of the EBRD's Sustainable Energy Initiative (SEI) addressing the challenges of climate change and energy efficiency. The aim of SEI in the Ukraine is to cut imports of fuel by supporting renewable energy production, such as through wind, solar, hydro and biomass. At the same time it will help to replace the ageing and polluting genera-tion inventory.

In support of projects that are often challenging to finance and implement, the USELF not only provides tailor-made financing, but also assistance to entities ranging from technical consultants to businesses and local authorities.

About Ukraine Sustainable Energy Lending Facility (USELF)

The Ukraine Sustainable Energy Lending Facility (USELF) is an investment facility of up to € 100 million established by the EBRD to support renewable energy projects in the Ukraine. The Facility provides debt finance as well as development support to projects that meet commercial, technical and environmental eligibility criteria. In addition, Clean Technology Fund (part of Climate Investment Funds) supports the Facility with € 40 million.

Target Projects

The Facility considers all forms of power generation from renewable energy sources including hydro, wind, biomass and solar. Biomass would come from sustainable sources and/or organic waste. Produc-tion and distribution of liquid biofuels are not eligible.

Eligibility Criteria

The general eligibility criteria are consistent with the EBRD's normal rules for direct lending for corporate or limited recourse projects as appropriate.

Eligible Companies:

- privately owned, registered and operating in the Ukraine
- operating in compliance with national environmental, health and safety legislation
- not engaged in activities prohibited under the EBRD's Exclusion and Referrals list (tobacco, alcohol, etc.).

Eligible Projects:

- replace electricity from conventional energy sources
- attain significant greenhouse gas emission reductions based on proven technology
- are financially viable.

Investment Appraisal

Investment projects are assessed by the EBRD on the basis of information made available by the sponsors (feasibility studies, business plan). Technical consultants prepare a project appraisal and supply EBRD with a technical, environmental and financial evaluation of prospective projects as well as provide legal support to the companies.
